The Bus Driver at the Norm Waitt Sr. YMCA provides safe transportation to and from program sites while maintaining a supportive, positive atmosphere that welcomes and respects all individuals.

- Complete thorough before-and-after trip checks each day and records all information, such as gas level, mileage, and maintenance on designated forms.
- Regularly check to make sure first aid supplies are fully stocked.
- Leave the bus tidy and clean after each use.
- Communicate regularly with other staff members and supervisor.
